### ROTARY EXPECTATIONS

- Prompt payment of initiation fee of \$200.00, corporate membership dues of \$450.00 per quarter for up to three (3) members, which is payable upon approval for membership. Membership dues include standard meals, Rotary International dues, district dues, and club dues for the primary and two designated members. The fee for each additional designated member is \$650.00, annually. Dues may be paid quarterly or annually. Annual payments are \$1,800.00.
- Each member is expected, but not required, to contribute a minimum of \$30.00 per quarter (or \$120 annually) to the Rotary Foundation. Once a member has contributed a total of \$1,000.00 or received a total of 1,000 points, he or she is recognized as a Paul Harris Fellow or multiple Paul Harris Fellow in honor of the founder of Rotary in 1905.
- Represent Rotary by living Rotary's Motto and Four Way Test.
- Regular attendance with dues paid in a timely manner. While regular attendance is preferred, we understand that there may be business demands that will restrict attendance from time to time. We will try to make our meetings available on our Facebook page as another means of attendance.
- Participate in club programs, activities, and committees when requested.
- Periodically provide suggestions or ideas for a relevant speaker or program.
- Strongly consider donating financially to The Rotary Foundation. All Rotarians encouraged to be "sustaining members" @ \$120 per year and there are a number of payment options available (i.e., automatic draft, online, etc.).
- Learn about Rotary, what it is, and what it does for our community and the world.
- Be prepared to give an answer when asked "What is Rotary?" (Begin by visiting web site, <https://www.rotary.org/en/about-rotary> )
